# 4 MATTERS ARISING AND NOT COVERED ELSEWHERE ON THIS AGENDA

There were no matters arising which were not covered elsewhere on this agenda.

# 5 PUBLIC PARTICIPATION

Speaking of his application for planning permission to erect an extension to his home together with the creation of an annex (PA23/01701), Mr Molcher stated that, if permitted, both developments will be used by adult members of his immediate family. The initial concept for the annex had arisen from a visit from a Planning Officer who was adamant that the ealier application for a two-storey extension to his home would be refused, not least because of its visual impact on the surrounding countryside.

# 6 CORNWALL COUNCILLOR'S COMMENTS

CCllr Keeling reported that

- he had attended a wide variety of meetings during the course of the month, including the final meeting of the Helston and South Kerrier Community Network Area
- at that meeting, discussions on the highway schemes to be taken forward were deliberated. The final decision is that of the five Cornwall Councillors, the community link officer and the highway manager, but he is confident that most, if not all, will be forwarded to the portfolio holder for final decision
- as announced, the Community Network Area will be replaced with the Community Area Partnership. He will
  shortly forward more information about their rôle and purpose. Nevertheless, it will include matters relating to
  governance and funding, together with other changes including the opportunity to comment on the council's
  business plan during the annual budget setting process
- a visit with members of the Customer and Support Scrutiny Committee to the call centre at Dolcoath, had revealed the extraordinary breadth of knowledge and demanding work being done by staff handling calls from members of the public
- the roll-out of 20's Plenty is expected to be implemented in the Helston and Kerrier area in 2025
- the Devolution Deal proposals and the question of whether or not Cornwall should have an elected mayor, is now off the table

• locally, he will follow up on an issue with trees, and the proposed cycle route (as discussed with Cllr Bell).

#### 7 Parish Matters

# The Coronation of HM King Charles III

The Clerk reported that the commemorative mugs marking the occasion of the coronation of HM King Charles III have now been delivered. The Chairman agreed to contact the school once the Easter holiday is at an end and both she and Cllr Bell offered to store the mugs until such time as the school can take them.

#### **Church Town Notice-Board**

Members considered a problem which has arisen concerning the addition of the panel detailing the walk through the Parish to the notice-board in Church Town. Cllr Bell explained that the intention had been to remove the existing map's surround and to site the new panel in the resultant space. The Clerk undertook to speak to Mr Sanders with a view to resolving the problem,

# St Germoe Closed Churchyard

Members considered an offer in the sum of £174.95 to extend the contract with Cornwall Council for cutting the grass in the closed churchyard at St Germoe's. The Clerk reported that the PCC undertakes this work and that the grant offered would be gratefully accepted. Cllr Mrs Doeser proposed, Cllr Bell seconded and it was agreed to accept the grant.

# Vacancy in the Office of Councillor

The Clerk reported that interest in standing for co-option as a Parish Councillor has been expressed by Dr Mike Peters.

Following discussion, Cllr Mrs Doeser proposed, Cllr Bell seconded and it was agreed that Dr Peters should be co-opted as a Parish Councillor.

Cllr Dr Peters signed and read aloud his declaration of acceptance of office before Mr Chapman, Clerk to Germoe Parish Council.

The Chairman welcomed Cllr Dr Peters to the Council.

Members noted that there remains a vacant seat on the Council.

PA23/01405 Mr and Mrs M.Rowe – Reserved Matters application for access, appearance, landscaping, layout and scale following Outline Approval PA20/01898 dated 16/07/2020 for the erection of an agricultural worker's dwelling to replace existing residential caravan – Tresowes Farm, Ashton. Cllr Mrs Doeser proposed Cllr Mrs Goddard seconded and it was agreed that this application should be returned with the following observation *Germoe Parish Council supports this application*.

PA23/01650 Miss A.Owen – Replacement of the existing roof tiles, roof-lights; addition of two sun-tunnels with extension to create a 20cm overhang; add external wall insulation and white horizontal concrete wood-effect cladding boards, remove existing chimneys and replace with a single flue on the south-east end; raise existing flat roofs to accommodate insulation – Quilkyn Hollow, Tresowes. Cllr Mrs Doeser proposed Cllr Bell seconded and it was agreed that this application should be returned with the following observation *Germoe Parish Council supports this application*.

PA23/01701 Mr and Mrs Molcher – Proposed extension and annex – Tremorvu Holidays, Tresowes Hill. Cllr Cllr Mrs Doeser proposed Cllr Bell seconded and it was agreed that this application should be returned with the following observation *Germoe Parish Council supports this application subject to the imposition of a condition requiring the use of both the extension and the annex to be ancillary to the use of the principal dwelling*.
