Minutes of the Ordinary Meeting of Germoe Parish Council held on Thursday August 28, 2008 at 7:00pm in the Church Hall. Germoe.

#### 1 APOLOGIES FOR ABSENCE

#### 2 DECLARATIONS OF INTEREST

## in items on the agenda

Cllr Mrs Clarke declared a personal interest in agenda item 9 Planning Application number PA08/01376/F Cllr Geake reported to Members that, in a professional capacity, he knows the agent for Planning Application number PA08/01406/O

of gifts (received as a result of being a member of the Council) of a value greater than £25. There were no declarations of gifts of a value greater than £25.

## 3 CONFIRMATION OF MINUTES OF THE LAST MEETING

Cllr Geake proposed, Cllr Martin seconded, all others in favour that the minutes of the Ordinary Parish Meeting held on Thursday July 24, 2008 are a true record and the Chairman signed them as such.

## 4 MATTERS ARISING AND NOT COVERED IN THIS AGENDA

The Clerk reported that, together with Councillors, he had met Mr Sharples from Cornwall County Council at Greenberry Downs on Monday July 30 at 10:00am to examine the possibility of replacing signage on the Downs and fencing-off of some of the more dangerous mine shafts. Mr Sharples warned that money for this sort of project is strictly limited, but hoped to be able to access funding to provide granite boulders with inset interpretation signs and warnings at either end of the Downs.

At the same meeting it had been agreed to look into the matter of applying for a Modification Order on the old road between Newtown and Rosudgeon and, with this in mind, the Clerk had spoken to the Clerk at St Hilary who had agreed to place the matter before his Councillors in September.

# 5 PUBLIC PARTICIPATION

Mr Sanderson again drew the Parish Council's attention to fly-tipping opposite the Motel on the A394. KDCllr Keeling again agreed to pursue the matter.

## 6 COUNTY AND DISTRICT COUNCILLORS' COMMENTS

Speaking of OneCornwall and his rôle on the Scrutiny Committee, KDCllr Keeling reported that

- there is a need to tighten procedural issues
- he has yet to be convinced that the twin concepts of equality and diversity, which should form strands of every aspect of government, are being embraced
- a recently formed Development and Support Group will provide training for new members of the Council and, possibly, pre-election training for potential members

- he had recently met officers from the Information and Development Agency and Centre for Public Scrutiny when scrutiny (which concerns itself with accountability, creativity and empowerment) had been high on the agenda. It is KDCllr Keeling's belief that, unless Scrutiny is wholeheartedly embraced by the new Council, there will be a significant threat to the success of democratic renewal
- under the new authority, Parish Councils will be able to ask their County Councillors to call for action on any issue which concerns them
- the Finance Sub-Group must produce a balanced budget for the new authority by March 11, 2009. However, there is no financial management process presently in place. It was noted that, in the past, an indicative budget would in place before the end of December
- the County lacks experience in many issues.

#### 7 POLICE REPORT

Through the Clerk, PCSO Mitchell reported that there have been no incident logs and no crimes reported since mid-July. PCSO Mitchell reminded residents to be on their guard against thefts from oil tanks.

## 8 FOOTPATHS, SIGNPOSTS, MAINTENANCE

Members considered the replacement of the notice-board at Great Work. The Clerk reported that he had successfully applied for a grant in the sum of £500 towards this project from the Cornwall Rural Community Council. He further reported that he had received a quotation from Tom Salkeld (who lives in Trewennack) for a custom-built board in European oak in the sum of £875. Cllr Mrs Clarke proposed, Cllr Mrs MacKenzie seconded all in favour that a new board should be ordered from Mr Salkeld.

The Clerk reported that he had received a grant from KDCllr Clayton (using his Portfolio Holder's allowance) in the sum of £300 to be used towards the regeneration of the area around St Germoe's Well.

It was reported that both Sam's Seat at Greatwork and the seat at the top of Moors Lane need the lichen cleaning from them: Cllr Felstead offered to do the work necessary at Great Work and Cllr Mrs Clarke offered to do the work at the top of Moors Lane.
