3 CONFIRMATION OF MINUTES OF THE LAST MEETING

Cllr Blencowe proposed, Cllr Mrs Clarke seconded, all others in favour that the minutes of the meeting held on Thursday February 7, 2013 are a true record and the Chairman signed them as such.

4 MATTERS ARISING AND NOT COVERED IN THIS AGENDA

There were no matters arising which were not covered on the agenda

5 PUBLIC PARTICIPATION

There were no members of the public present.

6 CORNWALL COUNCILLOR'S COMMENTS

CCllr Keeling reported that

- the proposed budget for the coming year (based on a 1.9% increase) was superseded by an amended proposal for a zero increase in the precept. This was adopted at a bad-tempered meeting of the full Council
- the decision will undoubtedly result in a reduction in services and an anticipated loss of one hundred and thirty jobs
- it is his contention that Cornwall needs greater financial flexibility and a model of delivering services commensurate with predicted future core government funding cuts
- the comments made by CCllr Colin Brewer concerning disabled children have resulted in his resignation from Cornwall Council
- Paul Masters, who held the post of Deputy Chief Executive Officer, has been selected to replace Kevin Lavery in the interim period. Kevin Lavery leaves the Authority with no payouts
- at a recent meeting, Councillors rescinded an earlier decision to increase members' allowances by 21%
- locally he has been kept busy with concerns voiced about pot-holes and mud on the roads.

7 POLICE REPORT

Through the Clerk, PC Wearne reported that in February a single crime (that of common assault) has been reported to the police. Similarly, a single crime was reported in the same period last year.

8 PARISH MATTERS

The Definitive Map

The Clerk reported that he had spoken to the Countryside Access Team Leader, Mike Eastwood, about the outstanding issues relating to the Parish Definitive Map.

The original paperwork to extend Footpath 13 through to the road has now been found and, if the landowner is still willing to dedicate the path, the matter will be expedited. Cllr Mrs Clarke stated that she would speak to Mr Rowe and let the Clark know his wishes.

The proposal to create a footpath from Tresowes Hill road to Tregonning Hill (WCA 532) is currently eighteenth on the list and it is anticipated that the necessary work will commence in 2015.

The proposal to create a footpath from Footpath 17 to the junction of Bridleway 32 and the County Road at Tresowes Green will be the next application to be considered (assuming the provisional results of a review of outstanding cases are agreed by Elected Members).

The Adit

Further to the collapse of the side wall of the adit just before Christmas, the Clerk reported that he had written to Andrew Richards at Cornwall Council as requested and was awaiting a response. The Clerk was asked to speak to Heritage Lottery about the possibility of obtaining a grant through the newly announced *Shared Heritage* programme.
