Cllr Geake proposed, Cllr Mrs Praed seconded all others in agreement that the minutes of the Ordinary Meeting held on Thursday February 2, 2017 are a true record and the Chairman signed them as such.

#### 4 MATTERS ARISING AND NOT COVERED IN THIS AGENDA

Cllr Mrs Whitehead reported that the second defibrillator training session, which had been attended by ten people, had gone very well – so well that requests from residents for yet further training had been received. The school had also expressed an interest in receiving training in the use of a defibrillator. Speaking on behalf of the Council, the Chairman thanked Cllr Mrs Whitehead for organising the training.

# 6 CORNWALL COUNCILLOR'S COMMENTS

CCllr Keeling reported that

- Cornwall Council has agreed a 3.97% rise in Council Tax: this will create an annual income for the Authority of £492 million
- 2% of this rise is earmarked for the provision of Adult Social Care within the county
- he had voted against the proposal because it is his belief that Central Government has a responsibility to finance the provision of Adult Social Care
- on average, Town and Parish Councils in Cornwall have increased their precept demand by some 8%. The average annual demand for the coming year from Town and Parish Councils on their residents is £110.54 per household (Germoe Parish Council is seeking £41.18 per household)
- all in all, it means that the total average annual rise on the Council Tax for a Band D dwelling is £65
- car-parking charges have been frozen
- he had hoped for an increase in the Highways budget, but this was not to be
- the proposal to bid for Truro to become the European City of Culture in 2022 is going ahead despite the fact that the United Kingdom will be out of Europe by then and that there are currently better ways to spend the money

• Cornwall Council is recommending a reduction in the number of Councillors in 2021 to a figure of ninety-nine. The Conservative group is looking for eighty-five although he feels that the optimum number would eighty-seven (which would work well with the existing Community Networks).

Cllr Blencowe questioned the reported increase of 8% in Town and Parish Councils' precept demands: CCllr Keeling said he would check the figures.
