3 CONFIRMATION OF MINUTES OF THE LAST MEETINGS

Cllr Ross proposed, Cllr Taylor seconded, all others in favour that the minutes of the Annual Parish Meeting held on Thursday May 3, 2012 are a true record and the Chairman signed them as being accurate.

MATTERS ARISING AND NOT COVERED IN THIS AGENDA

The Chairman reported that, despite the weather, the beacon had proved a great success. Speaking on behalf of the Council she thanked Balwest Methodist Chapel for the loan of the fire extinguisher and Cllr Geake and Cllr Taylor for the work they had done to make the evening a success.

The Chairman also thanked Cllr Royds for arranging the presentation of the commemorative mugs at Germoe School – an occasion she described as being a very happy one.

PUBLIC PARTICIPATION

Mr Rickard asked the Council's advice about a situation which has arisen concerning engineering works and vehicular use of Moors Lane and the privately owned lane outside his house. CCllr Keeling offered to look into the matter and, possibly, to contact Cornwall Council's Planning Enforcement Department.

CORNWALL COUNCILLOR'S COMMENTS

CCIlr Keeling hoped that all those present had enjoyed themselves both at the Olympic Torch Relay events and over the Jubilee weekend. He reported that

- Cornwall Council has voted to take the matter of the Stadium for Cornwall no further. However, under the Localism Act, a petition signed by 5,000 residents will require the issue to be revisited
- the Localism Act affords Cornwall Council the opportunity to review the existing cabinet system and, possibly, to revert to what some consider to be the more democratic committee system - and Parish Councils have been afforded the opportunity to comment on this

- the report on Council Tax recommends removal of the 10% discount on second homes (which is likely to be implemented). Other changes involve empty homes, granny flats and the localisation of Business Rates
- the chevrons for the corner at Boscreege have now been ordered and will be erected
- a sign on the A394 directing road users towards Germoe School may now, despite previous advice to the contrary, be possible
- the speed limits on the A394 from the Coach and Horses through to the east of Breage will be revised.
