The following planning applications were considered and the appended observations were returned to the Planning Authority. Each comment noted the fact that the decision had been returned using delegated powers

PA20/02119 Mr D.Fryer – Demolition and replacement of summerhouse and repairs to granite wall – Larkspur Cottage, Germoe Lane. *Germoe Parish Council supports this application*.

PA20/02199 Mr Hale – Detached domestic garage – Higher Westpoint, Tresowes Hill. The proposed garage would have minimal impact upon either the landscape or the setting of the Area of Great Landscape Value and the Conservation Area, additionally the design is consistent with that of the house. Consequently Germoe Parish Council supports the application.

PA20/02772 Mrs S.Fletcher – The proposed development is a timber construction stable block. The building will comprise of 3 x stables, 1 x tack room and 1 x barn/feedstore. The proposed site is a paddock belonging to our property with existing access. The proposed building is to provide shelter and security for our horses – Fox Cottage Tresowes. The proposed stable will effectively replace the previous stable adjacent to Foxes Cottage which is being converted to a residential dwelling.
