9 PLANNING

To make observations on planning applications including the following

PA22/09770 Mr and Mrs Elliott – Siting of a temporary dwelling (lodge) – Ocean View Barn, Germoe. Cllr Mrs Doeser proposed, Cllr Mrs Marshall seconded, Cllr Johnson abstained all others in favour that this application should be returned with the observation Subject to a condition requiring that the proposed lodge is removed and the land returned to its present use within three months of the completion of the main dwelling, Germoe Parish Council will support this application.

PA22/09771 Mr and Mrs Elliott – Construction of agricultural/garage building – Ocean View Barn, Germoe. Cllr Mrs Doeser proposed, Cllr Mrs Marshall seconded and it was agreed that this application should be returned with the observation Germoe Parish Council believes that the scale of this proposal is such that it will have an adverse and highly visual impact on the surrounding area contrary to CLP policies 2, 5, 12 and 25 and therefore requests the Planning Authority to refuse permission for development.

PA22/08346 APPROVED – Siting of two additional purpose built glamping pods on existing camping pitches with all year use – Tremorvu Holidays, Tresowes Hill – *noted*

PA22/08362 APPROVED – Demolition of existing dilapidated chalet and replacement with detached double garage – Pentreva, Newtown – *noted*

9 FINANCE

The Clerk presented Councillors with a statement of Germoe Parish Council's financial position as at December 1, 2022. A copy of that statement is attached to these minutes.

Members noted that the Clerk is still awaiting a reply from Barclays Bank plc concerning switching bank accounts.

Members considered a request from the Germoe Village Association both for a donation towards the cost of Christmas celebrations within the village and for those events to be included on the Parish Council's insurance policy. Following discussion, Cllr Mrs Doeser proposed Cllr Mrs Marshall seconded, all in favour both that under the terms of Section 137 of the Local Government Act 1972 the sum of £100.00 should be forwarded to the Germoe Village Association to be put towards costs relating to Christmas celebrations within the village and that those celebrations should be overseen by a Germoe Parish Council Advisory Committee (and that they would therefore be covered by the Parish Council's insurance policy). Cllr Bell will be a member of this Committee.

Members noted that the Clerk had earlier forwarded copies of anticipated income and expenditure for the coming Financial Year. Following discussion, it was proposed by Cllr Bell, seconded by Cllr Mrs Doeser all others in favour that the Precept for the year 2023/2024 should be set at £12,500.00

11 MEMBERS' QUESTIONS

Cllr Mrs Doeser reported that she had attended the recent Teams' meeting of the Community Network Panel. Attendees' attention had been drawn to the Levelling Up fund which is designed to target 'communities and space' and which will be administered by Cornwall Council using the Good Growth fund.

It was noted that Stithians reservoir is expected to be just 40% full in the Spring, which figure will necessitate the on-going imposition of a hose-pipe ban on households within the area.

Expressions of interest are invited from Town and Parish Councils who wish to promote small capital projects relating to highways within their boundaries.

Cllr Bell reported that he had joined a Zoom meeting concerning Neighbourhood Development Plans. There may be a way forward for Councils such as Germoe (for which Neighbourhood Plans are thought to be heavy handed) to have a greater say on development within their communities by adopting a 'Priority Statement', but the details of the scheme are still being worked on.
