The purchase of a gas-fired beacon for occasional use on Tregonning Hill

The Clerk reported that, as requested, he had ordered a gas-fired beacon from *Bullfinch (Gas Equipment) Ltd*, that it will be ready in February/March and that the Council will be contacted for payment at the time.

The purchase of commemorative mugs to celebrate the Diamond Jubilee of HM Queen Elizabeth II

The Clerk reported that, as requested, he had ordered forty commemorative mugs from Chown China with the Cornish coat of arms and the words *Presented by Germoe Parish Council* on the obverse for presentation to the children presently at Germoe School and to those resident in the parish but who receive education elsewhere. Cllr Royds undertook to speak to the Head Teacher of the school with a view to arranging a date for the presentation.

PA11/09344 IHCCG – Conversion of barn to form holiday accommodation and installation of oil tank (non material amendment to PA06/02077/F to include retention of opening on west elevation, addition of barn owl slot on south elevation, lintels over windows and doors on front face and increase of ridge height of building) – Wheal

Grey Mine, Tresowes. Cllr Mrs Clarke proposed, Cllr Royds seconded all others in favour that Germoe Parish Council should return this application marked "Germoe Parish Council considered this application on 5th January 2012 and determined that it had no observations to offer in this case.

"The Council noted that, to date, no hard copy of the application forms and supporting documentation have been sent to the Council, although the application appears to have been received by the planning authority on the 9th November 2011. Had the papers been forwarded to the Council on receipt it would have meant that they could have considered it at their meeting in December. As you appreciate, the Council has neither the benefit of computer links nor the ability to show computer generated information at its monthly meetings and is, therefore, dependant on hard copy both for its members and the public to view.

"The Parish Council notes that planning permission for this development was granted by the local planning authority on the 3rd January 2012. Whilst Germoe appreciates that the Local Planning Authority should attempt to determine applications within a reasonable timescale, they also recognise that it is incumbent on the Local Planning Authority to ensure that normal consultation procedures are properly completed. They note that the planning report indicates that apart from the Parish Council, there was no other public consultation on this application, which, whilst of a relatively minor nature, does immediately adjoin two listed buildings and is within a designated World Heritage Site. The Council would, therefore appreciate your comments as to why both the Parish Council and interested local residents appear to have been excluded from the normal planning processes in this case."

PA11/09804 Mr C Holmwood – Removal of Condition 2 attached to 2/09/79/00802/F dated 12 September 1979 (allow 12 month occupation) – Boscreege Caravan and Camping Park, Boscrege. Cllr Blencowe proposed, Cllr Mrs Clarke seconded all others in favour that Germoe Parish Council should return this application marked "Germoe Parish Council believes there were good reasons to place restrictions on this holiday site when planning permission was first given in 1979. No reasons to relax those restrictions have been submitted with this present application and Germoe Parish Council therefore objects to it and requests the Planning Authority to refuse permission."

PA11/10432 Mr J Reddell – Felling of one Sycamore tree – Rookswood, Germoe. Cllr Mrs Doeser proposed, Cllr Blencowe seconded all others in favour that Germoe Parish Council should return this application marked "No observations."
