#### 5 PUBLIC PARTICIPATION

# 6 CORNWALL COUNCILLOR'S COMMENTS

Through the Clerk, CCllr Keeling reported that during the course of the last month

- the main thrust of the Unitary Authority's work has been the setting of the budget. In much the same way as family budgets are under pressure, so the council's finances are being squeezed by Central Government. The Council Tax for the financial year 2014/15 will be increased by 1.97% which represents an increase on a Band D property of 47p per week
- the Unitary Authority will pass on the Council Tax Support Grant to Town and Parish Councils (which is based on the existing level of £1.754 million) and will continue to do so in future financial years
- he was disappointed that the members' Highways Budget has not been reinstated and had spoken out against this decision. It is his opinion that the loss of this money undermines the representative role of Ward Members which allowed people to make choices about highway matters at a very local level
- a new 'Roadmaster' road patching machine is currently being evaluated by CORMAC. It is a very impressive piece of kit which gives excellent results both quickly and efficiently
- he continues to pursue the possibility of a "Lengthsman Scheme" being piloted in the division and has
  again spoken about the matter to the Portfolio Holder for Transport and Waste, CCllr Bert Biscoe, who
  shares his enthusiasm for the scheme. Similarly, the Community Network Manager, Maxine Hardy, is very
  keen to get involved

Chairman's initials.....

- he was pleased to be able to attend an act of remembrance in each of the parishes this year, though the service on Armistice Day at the war memorial on Tregonning Hill was accompanied by very strong southwest winds, fog and rain and was quite bracing!!
- he has asked the Highway Steward to speak to Countryside Access to see if they can come up with a budget
  to clear the obstructions along Moors Lane though he added that it may be the land-owner's responsibility
  to keep the hedgerows cut and so prevent the ditches from becoming clogged and overgrown
- as Chairman of Governors for Germoe School, he has attended network meetings and training sessions
- there will be a special Christmas event on the 10<sup>th</sup> December at the school between 2.00pm and 6.00pm

#### POLICE REPORT

Through the Clerk, PCSO Paul Whitford reported that no crimes were reported to the police during November and further that during the course of the year to date only three crimes have been reported of which two have been detected and resolved.

### 11 FINANCE

Following discussion, it was proposed by Cllr Taylor, seconded by Cllr Royds all others in favour that the Precept for the year 2014/2015 should be set at £8,000.

Members considered a request from Balwest Methodist for financial help towards the upkeep of the cemetery at Balwest. Cllr Mrs Clarke proposed, Cllr Mrs Doeser seconded all others in favour, that, using the General Power of Competence (adopted by Germoe Parish Council on May 9, 2013), the sum of £300 should be made sent to the Trustees of Balwest Methodist Church for use in the maintenance of the cemetery.

The Clerk reported that owing to both his and the Chapel's oversight, the Parish Council has paid nothing for the hire of the Schoolroom since May 2008. The Council has held fifty-five meetings in the Schoolroom since that date and at a cost of £15 per meeting consequently owes the Chapel Trustees the sum of £825.00 Following discussion, Cllr Mrs Clarke proposed, Cllr Taylor seconded all others in favour that this long-outstanding account should be settled
