6 CORNWALL COUNCILLOR'S COMMENTS

8 PLANNING

Members noted that the following planning application received during the recess was returned using delegated powers with the attached observation

PA22/06889 Mrs T.Woodman – Application for Non-Material Amendment to decision notice PA18/08400 for the Erection of a dwelling, namely 1) all elevations being block work with white painted render but natural stone (granite) lintels and quoins on the south elevation – Geal Cottage Tresowes Hill. This application was returned marked *Germoe Parish Council has nothing further to add to its earlier comments*

To make observations on planning applications including the following

PA22/06388 Mr and Mrs Molcher – Proposed extension and associated works with the inclusion of a balcony on the south west elevation – Tremorvu, Tresowes Hill. Cllr Bell proposed, Cllr Mrs Marshall seconded and it was agreed that this application should be returned with the observation *Due to the height and form of the proposed development, the host building would be dominated by the extension and the character of the existing traditional stone cottage would be compromised contrary to the requirement of CLP Policy 12 Design Guidance.*

PA22/06889 NOT ACCEPTABLE AS AMENDMENT – Application for Non-Material Amendment to decision notice PA18/08400 for the Erection of a dwelling, namely 1) all elevations being block work with white painted render but natural stone (granite) lintels and quoins on the south elevation – Geal Cottage Tresowes Hill.– *noted*
