5 PUBLIC PARTICIPATION

Members of the public who attended were present to air their views on the future maintenance of St Germoe's Well. Councillors noted that

- the Well is sited on privately owned land (which precludes the Parish Council from bearing responsibility for its upkeep)
- the owner of the land is happy with the work that has been done
- Germoe Parish Council initiated the construction of the present-day well in 1977 and since then, from time to time, has paid for both its maintenance and repair
- the Church shouldered the responsibility for the day-to-day care of the well for many years
- the Village Association would like to refurbish the well and take on responsibility for its day-to-day maintenance.

6 CORNWALL COUNCILLOR'S COMMENTS

Through the Clerk, CCllr Keeling reported that in the course of the last month

he has been involved with a number of matters including the musical "Teenagers in a Garage" story from Praa Sands, coastal defence (which forms part of the Cornwall Devolution Deal), the appeal against the Planning Authority's decision to refuse the application from the Helston Railway and criticism in the local press following the report of the Local Government Association Peer review of planning procedures in the County

- as a former serviceman, he helped with the presentation of the Légion d'Honneur to Normandy Veterans in recognition of the gallantry and bravery displayed in the liberation of France during 1944-45
- locally, the signage at the eastern entrance to Ashton should be repaired and working soon
- there was a disappointing discussion on the "Lengthsman Scheme", but it afforded the opportunity to address the issue of overgrown hedges.

7 PARISH MATTERS

St Germoe's Well (The Queen's Silver Jubilee Well)

No additional projects were proposed. Members noted that the repair of the north-western wall of the Adit and the debrillator for Germoe Churchtown are both in hand.

HM The Queen's 90th Birthday

Members considered a proposal to light the beacon on Tregonning Hill to mark the occasion of HM The Queen's 90th birthday on April 21, 2016. Following a short discussion, Cllr Mrs Doeser proposed, and it was agreed that Germoe Parish Council should celebrate HM The Queen's birthday on April 21 by lighting the beacon. Cllr Geake and Cllr Taylor will set up the beacon and it will be lit at 10.00pm as part of the national chain. The occasion will not be advertised and the occasion will be strictly informal.

Cornwall Association of Local Councils

Members considered an invitation to subscribe to membership of the Cornwall Association of Local Councils for the year to March 31, 2017 in the sum of £198.88 + VAT. Following discussion, it was again agreed, again partly on the grounds of cost, not to subscribe to this Association.

Maintenance of the Closed Churchyard at St Germoe's

Members considered an offer to extend the contract with Cornwall Council for cutting the grass in the closed churchyard of St Germoe for a further year at the same annual rate of £76.22 Cllr Taylor proposed, Cllr Mrs Praed seconded all others in favour that, subject to the agreement of the Parochial Church Council, Germoe Parish Council should extend the contract with Cornwall Council.

10 REPORT OF CLERK AND CORRESPONDENCE

St Germoe PCC re Cornwall Council grant for cutting the grass in the Closed Churchyard and the proposed defibrillator – noted. Members agreed to forward the grant received from Cornwall Council for the maintenance of the closed churchyard to the Parochial Church Council which, traditionally, has undertaken this work

Cllr R.Royds notification of resignation from the Council – members noted Cllr Royds' resignation with sadness. The Clerk was asked to write to Mr Royds thanking him for all the work he has undertaken on behalf of the Council and to start the process for the election of a replacement Councillor

11 MEMBERS' QUESTIONS

Members stated that

- Planning Enforcement Officers appear to do everything in their power to avoid taking action against
 breaches of planning rules. This makes a mockery of reporting issues and further deprives residents of their
 democratic rights. It appears that all decisions on planning enforcement issues are weighed against their
 possible financial implications
- the Planning Authority is at fault in refusing to insist that the caravan is removed from the agricultural field OS 7075 at Balwest: it cannot, as has been suggested, be considered to be an agricultural building. Furthermore, the constant comings and goings in and out of the field and onto the lane represent a hazard to road safety. In response to an earlier planning application on the same site, Cornwall Highways observed that the fields should not be used for any purpose other than agriculture unless the entrance is improved: turning south towards Ashton from the fields is, of necessity, done blind
- the by-law banning dogs from beaches during the summer months should possibly be reviewed. The ban might be relaxed by restating the date from which the ban commences: Easter this year, for example, was particularly early. It was agreed that this matter should not be pursued by Germoe Parish Council.

12 CHAIRMAN'S COMMENTS

The Chairman drew members' attention to the enforced movement of local schools towards academy status and, as far as Germoe School is concerned (already working co-operatively with Boskenwyn in a federation) towards a multi-academy trust. Further information will be provided at a meeting (for parents) at Germoe School on April 13 and at an open meeting at Mullion School on April 20.
