3 CONFIRMATION OF MINUTES OF THE LAST MEETING

Cllr Geake proposed, Cllr Martin seconded, Cllr Davies and Cllr Taylor being absent from the last meeting abstained, all others in favour that the minutes of the Ordinary Meeting held on Thursday January 14, 2010 are a true record and the Chairman signed them as such.

5 PUBLIC PARTICIPATION

No members of the public were present.

6 CORNWALL COUNCILLOR'S COMMENTS

Through the Clerk, CCllr Keeling reported that

- just over a week ago, he had chaired a public meeting in Wadebridge Town Hall to hear the public's views on the options regarding the future of the council offices at Higher Trenant. It is the first time that a Scrutiny Committee has sought the view of the public and, as such, has set a precedent
- he had recently attended a cabinet meeting at County Hall at which the issue of the Isles of Scilly Link Partnership was discussed. A decision was taken to make every effort to secure planning permission and listed building consent for the works associated with option A (which comprise freight and passenger facilities on reclaimed land at the harbour, a pier extension and rock armour protection)
- subject to further debate, at the full council meeting on the February 16, Cornwall Council's net revenue budget for 2010/11 will be set at £451.904m with a Band D council tax of £1,244.41 (an increase of 2.9% on 2009/10). This represents an increase of 67 pence per week for Band D council tax payers.

7 POLICE REPORT

Through the Clerk, PC Vaughan reported that a single crime was reported to the Police in January 2010, the theft from a boat at the Clay Pit in Moors Lane. This compares to two crimes reported in January 2009.

8 PARISH MATTERS

Parking on the green at Balwest

Members noted that vehicles parking on the green at Balwest are spoiling this area by churning up the land and that this is exacerbated by rain-water run-off from the lane, which itself is in need of repair. Following discussion, it was agreed that, once the weather is more clement, repairs should be made to the green and consideration given to a way of preventing vehicular access. It is understood that, once the work at Tredrea is complete, an undertaking to reinstate the lane has been given. It was further noted that the Car Park notice in the field behind Balwest Chapel has disappeared and it was agreed that Germoe Parish Council would give due consideration towards underwriting the cost of a replacement.

Village Design Statement

Members noted that the informal meeting to discuss changes and additions to the draft Village Design Statement which was arranged at the last Parish Council meeting had, of necessity, been postponed. It was agreed that the postponed meeting will now be held on Monday February 22 at 2:00pm in the Chairman's home.

PA09/01648/F Bronzemill Limited – Demolition of existing motel and associated buildings and erection of eighteen self-catering units of holiday accommodation – Cornwall Motel, Main Road. Cllr Geake proposed, Cllr Mrs Clarke seconded, all others in favour that Germoe Parish Council should return this application marked with the following observation "Germoe Parish Councillors strongly support Breage Parish Council's observations on this application and particularly the stated desire to see a mixture of affordable housing and unfettered development. Additionally, they express their surprise and regret that the submitted plans do not supply details of the drainage of foul water and effluent from the site or proposals for communal lighting. They believe that the application as it stands is contentious and therefore request that it should be decided at an open meeting of the Planning Committee."

12 MEMBERS' QUESTIONS

Cllr Mrs Doeser asked if Germoe Parish Council would agree to send an open letter of support for the publication of a Local Food Guide to Transition Helston. Such a letter would be used to attract funding to underwrite the cost involved. She pointed out that, were the Parish Council to take this step, it would be in line with the Vision ("to ensure access to more locally grown fresh produce") identified in Parish Plans published in April 2004. Following discussion, the Clerk was asked to write to Transition Helston offering Germoe Parish Council's support for the project.

Cllr Mrs Clarke reported that South West Water has finally removed the switch box (which had been left open for the past three years) from the road verge just below the reservoir and replaced it in a secure underground chamber.

Cllr Geake reported that the Chapel and Balwest Heritage Group are combining to stage an event (which will be part of the Festival of British Archaeology) on July 24. The present intention is to serve cream teas and to lead guided walks of the historic monuments on Tregonning Hill.
