1 APOLOGIES FOR ABSENCE

3 CONFIRMATION OF MINUTES OF THE LAST MEETING

Cllr Blencowe proposed, Cllr Mrs Clarke seconded, all others in favour that the minutes of the Meeting held on Thursday December 2, 2010 are a true record and the Chairman signed them as such.

4 MATTERS ARISING AND NOT COVERED IN THIS AGENDA

The Clerk advised Members that the road salt has been delivered and is in store. It was agreed to post notices on the boards advising residents that the Parish Council has a small store of road salt and giving contact numbers in case of problems relating to snow and ice.

5 PUBLIC PARTICIPATION

It was noted that there was support for an advisory road sign at the point where the lane to Boscreege joins the Balwest to Greatwork road.

6 CORNWALL COUNCILLOR'S COMMENTS

CCllr Keeling reported that

- it is his belief that Cornwall Council behaved responsibly in setting an Emergency Budget in early December. The budget for the coming financial year shows an income shortfall of £53.7 million which the Authority will have to cover by making savings and efficiencies
- collective agreement concerning redundancies consequent upon this income shortfall is close: such redundancies are unfortunate but necessary and will allow the Authority to move on
- his work as the Chairman of the Scrutiny Committee goes on: the areas currently under examination are transparency, management and alternative service provision
- he believes strongly that Planning Officers' comments on potentially contentious applications should be provided to Town and Parish Councils before they formulate their observations
- a pot hole hotline is available on the Cornwall website for residents to report problems on the highway.

In answer to a question concerning the proposed solar farm and the pre-application process, CCllr Keeling said that he would contact the Planning Officer to ask that Germoe Parish Council should be formally involved.

7 POLICE REPORT

Through the Clerk, PC Vaughan reported that a single crime (that of a burglary in Tresowes) had been reported to the Police in December 2010.

8 PARISH MATTERS

In the light of figures published by Cornwall Council in November 2010 suggesting that there is presently an identified need for the building of twenty-one affordable dwellings within the Parish of Germoe, Members considered a proposal to commission a Local Needs Affordable Housing Survey. Following considerable discussion, it was agreed that members should consider the questions that might be posed in such a survey and that the matter should again be debated at the meeting in February.

9 PARISH COUNCIL MATTERS

Members noted that once again there has been no progress in the search for residents willing to stand for co-option as a Parish Councillor.
