## 3 CONFIRMATION OF MINUTES OF THE LAST MEETING

Cllr Mrs Doeser proposed, Cllr Mrs Clarke seconded all others in favour that the minutes of the Meeting held on Thursday November 3, 2011 are a true record and the Chairman signed them as such.

# 4 MATTERS ARISING AND NOT COVERED IN THIS AGENDA

Cllr Geake reported that, despite what he had said at the last meeting, he had been unable to attend the Cornwall Conversations event with the Leader of the Council at County Hall.

Cllr Mrs Clarke reported that she had fielded a number of complaints concerning inconsiderate owners of dogs failing to clean up after their pets. The Clerk agreed to forward a number of designated area notices to her for distribution.

Cllr Blencowe reported that the wall-mounted notice-board is now in his care. This led to discussion during the course of which it was noted that the boards at Balwest and at Nevada House are reaching the end of their lives.

#### 5 PUBLIC PARTICIPATION

There were no members of the public present.

#### 6 CORNWALL COUNCILLOR'S COMMENTS

CCllr Keeling reported that at Cornwall

- a recently agreed recommended budget will be presented to the full Council in February
- if Cornwall Council makes no increase in the precept demanded from residents, it can access funding from Central Government equivalent to 2.5% of the budget
- however that grant comes with conditions which may create difficulties in future years and therefore it may be that the Council will seek a 2.5% increase from its residents
- criticism, with which he does not agree, has been voiced that far-reaching financial decisions are being made too early in the year
- he has replaced Mike Clayton as a member of the Planning Committee
- he has accepted the position of Deputy Leader of the Independent Group of Councillors
- the 10% discount on the Council Tax presently afforded to second homes will end in 2013

Chairman's initials.....

- the Council is looking at discretionary rate relief for small businesses and community interest groups and locally
  - the Penwith Access and Rights of Way Group has agreed to cut out Whippers Lane
  - the chevrons at Boscreege have yet to be installed, but he is dealing with the matter
  - the Olympic Torch will be carried along the A394 through Newtown, Ashton and Breage.

#### 7 POLICE REPORT

Through the Clerk, PC Vaughan reported that a single crime, that of criminal damage to a vehicle near Tresowes, had been reported to the Police during the month of November. He again reminded members and residents alike that the new non-emergency number is 101 and added that the annual Christmas period Drink Drive Campaign has started.
