The Chairman welcomed members and visitors to the January meeting.

1 APOLOGIES FOR ABSENCE

CCllr Keeling, Cllr Mrs Clarke, PC Wearne and PCSO Sadler sent their apologies for absence.

2 DECLARATIONS OF INTEREST

3 CONFIRMATION OF MINUTES OF THE LAST MEETING

Cllr Ross proposed, Cllr Royds seconded, all others in favour that the minutes of the meeting held on Thursday December 6, 2012 are a true record and the Chairman signed them as such.

4 MATTERS ARISING AND NOT COVERED IN THIS AGENDA

There were no matters arising which were not covered on this agenda.

5 PUBLIC PARTICIPATION

Mrs Seargeant stated that she was present simply to listen to the proceedings.

6 CORNWALL COUNCILLOR'S COMMENTS

CCllr Keeling being absent, there were no comments from the Ward Member.

7 POLICE REPORT

Through the Clerk, PC Wearne reported that in December no crimes were reported to the police. Similarly, no crimes were reported in the same period last year. Parishioners are asked to take steps to secure their property and to remain vigilant to any suspicious vehicles or activity within the area.

8 PARISH COUNCIL MATTERS

Members considered a request for a response to the *Cornwall and West Devon Mining Landscape World Heritage Site Management Plan 2013-2018*. Cllr Blencowe proposed, Cllr Ross seconded all others in favour that the response drafted by the Chairman and circulated earlier should be adopted and forwarded to Cornwall Mining.

9 PARISH MATTERS

The Notice-board at Balwest

Members considered the replacement of the notice-board at Balwest. Cllr Ross proposed, Cllr Taylor seconded all others in favour to commission a replacement board (in oak and similar to those already in position) from Bear Joinery at a cost of £1,056 – the contractor to remove the old board.

The Adit

Members noted that the wall of the adit collapsed just before Christmas. The area is clearly dangerous and will need repair. It was further noted that

- Cornwall Highways had been most helpful in blocking the entrance from the road within hours of the collapse being reported
- some years ago an extensive search for the owner of the adit had proved fruitless
- as a result, the Parish Council had decided to maintain the area at public expense
- however, the fabric itself is not covered under Germoe Parish Council's insurance
- in 2010 the owners of The Old Pottery had been asked to trim the hedge: no reply had been received.

Further enquiries following the collapse of the wall have revealed that the adit

- is mentioned in a document written by D.W.M.Chidell and entitled Report on chutes, springs, wells and other public untreated water supplies in Kerrier District previously or still administered by Kerrier District Council and published in May/June 2004
- and clearly, historically, formed part of the District Council's public health remit/duties
- which equally clearly, suggests that it was considered to belong to Kerrier District Council (since the Authority did not have the power to maintain property belonging to somebody else)
- is a Grade II Listed Building (List Entry Number 1142163).

Concerns were expressed that

- inaction would lead to the loss of this important and unusual historic structure sited within the World Heritage Site and a Conservation Area
- further falls are inevitable and will eventually block the well which will result in water flooding across the road.

The Clerk was asked to contact Cornwall Council about what is clearly the Authority's property explaining Germoe Parish Council's interest and to seek urgent repairs.

PA12/11299 Mrs Dianne Whitehead – Construction of extension to entrance porch with disabled ramp and entrance leading to porch and various internal works – Germoe Church Hall. Cllr Blencowe proposed, Cllr Ross seconded all others in favour that Germoe Parish Council should return this application marked "Germoe Parish Council welcomes the proposed internal alterations and strongly supports them. However, the Parish Council has strong objections to the bulk and design of the proposed external alterations and additions to this important historic building set within the Conservation Area and therefore requests the Planning Authority to refuse permission for development."

13 MEMBERS' QUESTIONS

Cllr Taylor voiced his concerns about the deterioration of the road network within the Parish. In particular he drew members' attention to the stretch of road between Tresowes Green and Greenbank where the surface is disintegrating and the edges have been eroded. It was agreed to alert Cornwall Highways to these concerns and to draw the Highways' Authority's attention to those minor roads (especially those roads between Tregonning Hill and the A394) along which there are few adequate passing places but where to draw off the road onto the verge risks vehicle damage.
