## Six Walks through the Ancient Parishes of Breage and Germoe

The Clerk reported that re-working of the notice-board route map and associated pictures had not proved quite as straight-forward as he had initially been led to believe. The manufacturer requires either the original documents or a high-resolution scan of the board and re-working will not be cheap. However, he has traced Mr John Dale, the original designer, but Mr Dale no longer possesses the original digital working. He has, however, expressed a keen interest in re-working the design and has asked for a high resolution scan of the existing board, which the Clerk has now acquired. This is currently on the way to Mr Dale and therefore the project is again underway.

#### 8 PARISH MATTERS

## **Climate Change**

Cllr Blencowe reported that the recent Planning Conference had revealed that Climate Change is cited as the foremost priority in the Prosperous Cornwall 2050project (which brings together plans and strategies from across Cornwall Council, including the Local Transport Plan, the Housing Strategy, the Local Skills and Labour Strategy and a plan for Communities). It remains Cornwall Council's aim for the county to be carbon neutral.

# The Queen's Platinum Jubilee (Thursday June 2, 2022 to Sunday June 5, 2022)

The Chairman reported that she, Cllr Mrs Doeser, Cllr Foster, Mrs Willett and Mr Coward had met on Tuesday evening to discuss ways in which this landmark might be celebrated by the community. Suggestions had included

- planting red, white and blue flowers in troughs and pots sited along the Church wall on Germoe Green and elsewhere within the parish
- putting up bunting (whether bought or home-made is up for question)
- lighting the beacon on the Preachers' Pit on Thursday June 2 at 9.15pm
- presenting commemoration mugs both to the children attending the school and to older school-age residents
- a tea-party on Germoe Green with an especial invitation to the oldest and the youngest residents
- liaising with Breage Parish Council to avoid clashes
- the next meeting will be on January 12, 2022.

#### 9 PLANNING

## To make observations on planning applications including the following

PA21/10623 Mr N.Oliver – Refurbishment of existing dwelling house including extension and alterations and siting of garden studio and associated works – Chywoon Farm, Chywoon Lane, Rosudgeon. Cllr Blencowe proposed, Cllr Mrs Doeser seconded and it was agreed that this application should be returned with the observation *The proposed garden studio would provide additional residential accommodation detached from the main dwelling. The proposal does not meet any of the special circumstances set out in CLP Policy 7 for building a New Dwelling in the Countryside and is therefore contrary to the Cornwall Local Plan.* 

The proposed development in the Cornish Mining World Heritage Site is not supported by an evidence based Historic Environment Assessment and Evaluation contrary to the requirements of the Cornwall Local Plan Policy 24.

Germoe Parish Council therefore requests the Planning Authority to refuse permission for development.

#### **Decisions**

PA21/07663 APPROVED – Demolition of existing and erection of replacement house, with associated parking amendments and new field access – Gwel An Bleydh (formerly Stony Acres), Balwest – *noted* 

Cllr Blencowe reported that the recent Planning Training Conference had referred to the ideas and concepts contained within the thinking behind the Prosperous Cornwall 2050 document and also to the concept of place design in which the long-term effect of future development is evaluated.

## 10 FINANCE

The Clerk presented Councillors with a statement of Germoe Parish Council's financial position as at December 2, 2021. A copy of that statement is attached to these minutes.

Members noted that the Clerk had earlier forwarded copies of anticipated income and expenditure for the coming Financial Year. Following discussion, it was proposed by Cllr Blencowe, seconded by Cllr Mrs Doeser all others in favour that the Precept for the year 2022/2023 should be set at £10,100.00

#### **Police Report**

The Chairman welcomed PCSO Berry to the meeting. PCSO Berry said she was sorry not to have attended quite as frequently as she would have liked, but reported that the incidence of crime within the parish is very low. Nevertheless, she urged residents to report each and every incident to the Police. The Police can only react to a definitive report: hearsay alone is not sufficient. She has been working in schools for the past few months – assessing traffic behaviour outside the gates and teaching the children road-safety. She is due to visit Germoe School early in the New Year. A new Tri-Service Officer has been appointed to Helston: he has been working with elderly residents and has been fitting smoke detectors and offering advice about fire prevention.

Cllr Mrs Doeser referred to the Godolphin Cross Community Association and to its Out-Reach project, which is designed to help those who are housebound, lonely or finding life harder within the communities of Godolphin Cross and the Parish of Germoe. It is likely that the Association will need some financial help in the new financial year and it was agreed to invite Mrs Rona Laity, the GCCA outreach worker, to attend the meeting in January.
