Cllr Blencowe proposed, Mrs Praed seconded and it was agreed that the minutes of the Ordinary Meeting held on Thursday November 1, 2018 are a true record and the Chairman signed them as such.

Giving voice to members' thoughts, Cllr Mrs Praed said that it had been heart-warming to see so many people at the War Memorial for the Remembrance Day Service.

## 5 PUBLIC PARTICIPATION

Mr Chizhikov said that he was present to support Mr Hoben's application for a new dwelling at Stoney Acres. He noted that, at present, the Cornwall Council website contains no adverse comment and added that proposals for similar conversions had recently been approved. This application is in line with the recommendations contained in paragraph 55 of the National Planning Policy Framework and Policy 7 of the Cornwall Local Plan. In general, the applicant's aims had been for a sympathetic development, for an attractive building that will sit well within the landscape, will be sustainable and of low impact.

# 9 PLANNING

# **Applications**

PA18/10308 Mrs C.Rampley – Partial demolition, extension and conversion of existing redundant rural building to form a single dwelling and installation of a domestic packaged sewage treatment plant – Stony Acres, Balwest. The Chairman proposed, Cllr Bell seconded and it was agreed that this application should be returned with the following observation *By virtue of size, bulk and position within the site, the proposed building would significantly increase the linear-built residential form in this prominent position, and consequently would impact negatively upon the open countryside and negatively upon the public view of Tregonning Hill from roads to the south-west of the hill.* 

The Parish Council considers that the sympathetic choice of construction materials and energy-efficient design do not outweigh the potential negative impact upon the immediate setting and upon the surrounding open countryside.

Chairman's initials.....

The Parish Council does not consider that the potential negative impact to the rural nature of the development will be outweighed by public economic and social benefits.

Germoe Parish Council objects to the proposed development because there will be no Enhancement to the Immediate Setting and there will be visual harm to the Open Countryside contrary to the requirement of the Cornwall Local Plan Policy 7 and because there will be harm to the Area of Great Landscape Value caused by the cumulative development on the south west face of Tregonning Hill contrary to the requirements of the Cornwall Local plan Policy 23.

#### 12 MEMBERS' OUESTIONS

Speaking on behalf of the Germoe Village Association, Cllr Bell asked what had become both of the Community Emergency Plan and the proposed memorial for the four airmen from Coastal Command who had died in 1941 when their plane had crashed into County Quarry on Tregonning Hill. The Chairman replied that the Parish Council had delivered leaflets to all the houses in the Parish concerning a proposed Community Emergency Plan but had received not a single reply. The memorial for the airmen as proposed by the Balwest Heritage Society would have been sited in the Parish of Breage and at the edge of a very steep drop and the idea had been dropped.
